



## YOUTH ARREST EXPUNGEMENT WORKSHOPS

In an effort to assist our young citizens with cleaning their records, State Attorney Dave Aronberg’s team will host **YOUTH ARREST EXPUNGEMENT WORKSHOPS on June 21, 2018 and again on June 28, 2018.** We are joined in this effort by Sheriff Ric Bradshaw, Clerk/Comptroller Sharon Bock and your Board of County Commissioners.

If you are under age 21 and have a prior arrest as a juvenile or an adult, your case may be eligible for expungement. Complete a **State Attorney Youth Arrest Expungement Application** and send it to us immediately. Once we receive this application we will determine your eligibility and start preparing the documents. You will then need to join us at one of our Expungement Workshops. At the workshop we will help you with the paperwork and fingerprints needed to complete your formal FDLE application.

## INSTRUCTIONS

**PLEASE MAKE SURE YOU WRITE LEGIBLY. WE WON'T BE ABLE TO HELP YOU IF WE CANNOT READ YOUR WRITING.**

This application is only for youth currently age 20 and younger. This information is what we will need to access your official arrest record and determine your eligibility for expungement.

On the top portion of the application you simply fill out basic information about yourself. On the bottom of the application you will need to place an "X" next to the workshop location you want to attend. Two locations are available on June 21<sup>st</sup> and two are available on June 28<sup>th</sup>. If you cannot make either date please let us know and we will save your application for a future workshop. It can take the Florida Department of Law Enforcement (FDLE) up to six months to process your application, so try not to delay.

Once we have your application we will start preparing your workshop paperwork. On June 21<sup>st</sup> or 28<sup>th</sup>, we will have your paperwork waiting at the workshop you chose on the application. We will have our workshop teams ready to assist you from 9:00am – 5:00pm. Come anytime during the day. The actual workshop will take just about an hour, but please understand that there may be a line of youth ahead of you so your wait time could be longer.

Your formal record of arrests is maintained by FDLE. It can also be accessed by certain schools and businesses. Taking the time to expunge (delete) whatever arrests you can from your record will certainly help you achieve your future goals. Our workshop will help you prepare your FDLE expungement packet, including your fingerprints, for FREE.

FDLE, however, charges \$75.00 to process this packet for two of the arrest categories. But if you are expunging an arrest that was resolved by your successful completion of a juvenile diversion program they will process the packet for FREE. Don't let the possible fee stop you from sending us your application and attending the workshop. We can get everything else ready for you so once you have the fee you can add it to the packet and mail it to FDLE for processing.

If you would like to fill out the application by email, send us your request at [StateAttorney@sa15.org](mailto:StateAttorney@sa15.org) and we will send you an email that you can complete and return or simply scan the completed application and email it to us at the same address. You can also mail it to Administration Dept. State Attorney's Office, 401 N. Dixie Highway, West Palm Beach, FL 33401, or you can hand-deliver it to one of our offices listed on the application.
